**New Business:**

Gerrells was late in getting invoice to Coach Horner for payment of sweatshirts/pants from the 2014-15 season.

There was discussion on how to handle future distribution of travel gear, warm-ups, and fundraising for this gear. The school district does not provide warm-ups. Last season, not all players paid for or sold the \$200 fundraiser requirement, although every player received travel gear. Setting up player expectations and selling requirements need to be discussed prior to next season. Coach Horner may be able to use summer camp money to help pay for next season warm-ups.

In order to help with budgeting, all purchases requiring reimbursement by the booster club must have prior approval.

H5, Coach Horner's web hosting company, has a yearly fee. Coach Horner and Lonnie Bosch will continue to keep up the site. Lonnie Bosch will add officer information.

In addition to camping/water activities, other possible activities include workouts at the Glen Ullin gym and golfing. 4 campsites are reserved. Coach Horner will use one campsite; other parents are welcome to use any of the other 3. Coach Horner will continue to provide additional information.
